**A RESOLUTION OF THE DEL NORTE COUNTY BOARD OF SUPERVISORS EXPRESSING
APPRECIATION AND COMMENDATION FOR THE MANY ACCOMPLISHMENTS OF THE DEL
NORTE ASSOCIATION FOR CULTURAL AWARENESS**

WHEREAS, the Del Norte Association for Cultural Awareness (DNACA) was organized by the Board of Supervisors in 1981; and

WHEREAS, since that time DNACA has grown and matured into a rural arts council that is respected on a statewide level; and

WHEREAS, DNACA's accomplishments include:

- a) A performance series which imports five performing artists of national or international caliber to the County each year;
- b) Engagement activities in which the performing artists brought to Del Norte County give workshops in the K-12 schools;
- c) A courtesy seat program whereby local businesses and individuals make significant contributions to provide complimentary tickets for foster children, low-income elderly, special education students, etc.;
- d) An Arts in Education program whereby local artists provide visual and performing arts workshops in the Del Norte County School District, grades K-8;
- e) A weekly arts calendar in the local newspaper and online, which keeps citizens aware of artists and art events;
- f) Rotating Art in Public Places exhibits that showcase the works of local visual artists;
- g) Support to local artists, art organizations and residents about grants, events, California Arts Council Programs and other arts information;
- h) An Arts for Veterans program, which provides free arts workshops to local veterans and their families; and
- i) A Poetry Out Loud program, empowering local high school students to study great poetry.

WHEREAS, through these programs DNACA has served a widespread constituency county-wide during the last year; and

WHEREAS, Del Norte residents have demonstrated their support of DNACA programs by repeated participation;

NOW, THEREFORE BE IT RESOLVED, that the Board of Supervisors of the County of Del Norte, State of California, as follows:
